How's Your PCI-DSS Compliance Status??

Over the past several weeks - we have entertained numerous phone calls and email conversations concerning individual CCB's PCI-DSS Compliance documentation. As referenced in a previous communication - "The PCI-DSS applies to all entities that store, process, and/ or transmit cardholder data. It covers technical and operational system components included

in or connected to cardholder data. If you are a merchant who accepts or processes payment cards, you must comply with the PCI DSS." Generally, your Merchant Account Provider will communicate with you as to their requirements for you to be PCI-DSS compliant - and perhaps provide a mechanism for you to do so. As with ICCS, each CCB should now be utilizing the PCI Security Standards Council's SAQ-A, Version 4.0 (Self-Assessment Questionnaire-A). The previous Version 3.2.1 became obsolete on March 31st and is no longer accepted. Various Merchant Account providers may have different requirements and procedures. To assist you with your compliance efforts, we have placed five



Documents in the MYCOUNTYPARKS.com > PCI COMPLIANCE 2024 file in the IACCB Portal. (Shown to the left) Feel free to utilize the "FULL ICCS " PDF as a reference when filling out the one for your CCB - changing names & local information as appropriate. We have also included a blank/fillable .DOCX version of the PCI-DSS SAQ-A V.4.0 - which also includes an "Attestation" portion that can be signed/uploaded as needed depending on the requirements from your Merchant Account Provider. One of the newer standards that will be enforced by 2025 (and may be required by your Merchant Account Provider in 2024) is a certified "Vulnerability Scan" of your connections to the website - this may be completed by a third-party entity (ie: Security Metrics), depending on requirements as determined by your Merchant Account Provider. For additional information on PCI-DSS Compliance, we encourage you to consult with/visit your Merchant Account Provider administrative pages or the PCI Security Standards Council website via the following LINK: https://www.pcisecuritystandards.org/

1. Attestation of Compliance from PCI SSC (SAQ-A) - approved by Client; 2. Certificate of Validation as provided from your Merchant Account Provider, etc.; 3. SAQ-A Version 4.0 as filled out by ICCS/MCP.com for compliance - full 20-page document with MCP.com technical details; 4. SAQ-A Version 4.0 as autofilled by the attestation process by EVO Payments - the ICCS/MCP.com Merchant Account Provider; 5. Blank SAQ-A Version 4.0 that is digitally fillable by any CCB that needs the most current version.


IMPROVEMENTS CONTINUE!



As development work continues on the new website, so do the improvements to the existing site in preparation for migration to "the new".

An **Event Registration Checkout** improvement includes modifying the verbiage for <u>FREE</u> event "purchases" by changing the "Billing Information" title on the page to "Checkout Information". This will hopefully diffuse any dissuasion that customers may have in completing their registrations.

In conjunction with the rollout of the **QR Code INSTANT PAY option** for campsite registrations, we have modified the facility listings. The phone numbers associated with these facilities have been removed, and the text on the listing button has been changed to "more information". The facility home pages for each of these facilities have also been modified so as to demonstrate that they are not reservable in advance, and to note their new "Pay on Site" only availability.

Enhancing Your CONTACT US Response Emails

Many of you have seen the **CONTACT US inquiries** that come through the MCP.com system to your email in-boxes. We have noted that very few of you are taking advantage of the text box in your County Admin that allows you to provide additional information on the confirmation email receipt to your customers – it is on your Dashboard for County Administration (below).

We have included a sample customer confirmation email that a user receives following the submission of a CONTACT US inquiry. (Left) The section between the dotted lines (- - - -) is auto-generated from embedded information about your county on our website. If you would like your office hours to appear within this email – let us know, and we will install it.

Otherwise – we encourage all of you to take advantage of this opportunity (below) to provide additional info. and/or notice to your users!

Over the past 18 months, we have introduced THREE Q.R. Code Generators to MyCountyParks.com - it DOES matter which one you utilize for what purpose - as follows:

- For EVENTS use the generator embedded in the Event Admin (#1 Above) "Static" QR Code
- For FACILITIES use the generator embedded in the Facility Admin (#2 Above) "Dynamic" QR Code(s) (Be sure to specify to be used for Advanced Reservations, Instant Pay at Site, or Availability Calendar)
- For GENERAL GENERATION for all other QR Code generations of Non-MCP.com URLs, and URLs within MCP.com that are unrelated to either Events or Facilities. (#3 Above)




These two QR codes are both for the identical facility, and were both generated within MCP.com – one from the Facility Generator, the other from the General Generator. They are clearly different, and one is Static while the other is a Dynamic code. Due to these differences, and depending on the camera or code reader being used - they may provide slightly different results. THEREFORE – when generating Event or Facility QR Codes for registration or reservations be sure to use embedded generators within those items!


